<u> VOTER REGISTRATION -</u>

Maine residents may register to vote anytime, including the day of the election. You must be 18 years of age and a resident of the City of Gardiner. Proof of residency and proof of identity is required, such as a driver's license indicating a physical street address in Gardiner (not a post office box or mailing address).

If you are currently registered and wish to change any information such as a married name or residence, please visit the office or mail the new information to the City Clerk, 6 Church Street, Gardiner, Maine 04345. Enclosed is a voter registration application for your convenience.

#### ~<u>TAX INFORMATION</u>~

NOTE: NEW OWNERS DO NOT RECEIVE TAX BILLS AUTOMATICALLY, PLEASE CALL 582-2223 FOR A COPY.

Real Estate and Personal Property Tax Bills are mailed in August, with a reminder post card mailed in February.

SEPTEMBER 15 - 1st Half Installment MARCH 15 - 2nd Half Installment

Interest is charged starting the day after tax due dates. Real Estate Liens are recorded each June for unpaid taxes.

#### SEWER BILLING~

Sewer billing is done on a quarterly basis through the City Hall front office. Payment may be sent through the U.S. Mail or by walking in and using the front counter.

Residential Summer Discount – If you use water outside your home for lawns, gardens and swimming pools, you may be eligible for an adjustment in your sewer user fees. Please call 588-4070 for more information.

~ DOG LICENSES ~

\$6.00 per year for spayed/neutered dogs \$10.00 per year for dogs not spayed/neutered \$15.00 late fee after January 31st of each year

All dogs 6 months and older must have a license. In order to obtain a license for your dog, the owner must provide a <u>current</u> State of Maine Rabies Certificate. If your dog has been spayed or neutered please bring that certificate with you.

If you cannot appear in person at City Hall to re-license your dog you may do so through the mail by sending a copy of the current rabies certificate and appropriate fees. Our mailing address is City Clerk's Office, 6 Church Street, Gardiner, Maine 04345.

#### -HUNTING and FISHING LICENSES-

#### **Hunting Licenses**

Applicants for an adult (16 yrs. & older) hunting license must show proof of having previously held an adult license to hunt with firearms in any year beginning with 1976 or successful completion of an approved hunter safety course. Residents must provide proof of residency.

#### Fishing Licenses

Any resident of this state 16 years of age and older must purchase a license in order to fish in inland waters.

#### MARRIAGE LICENSES

#### Filing Intentions

The first step in filing a marriage license is to have the marriage intentions recorded in writing. Both parties must sign the intentions, stating they are free to marry. You must be 18 years of age to marry without parental consent. If you have been married before and are divorced or widowed, a certified copy of documentation showing how the last marriage ended is required. If you live in separate towns, you only need to file one copy. Once you have filed your intentions, you will be issued a license immediately.

#### Obtaining Your Marriage License

Once the intentions have been filed and the bride and groom have signed the marriage license, the marriage license may be issued to the bride and groom. The license must be used within 90 days from the date the intentions were filed. The cost of obtaining a marriage license is \$30.

#### Copies

Copies of your marriage certificate is only available from the municipal clerk(s) who issued your license. However, copies may also be obtained from the Office of Vital Records. A \$10.00 fee does apply for a certified copy.

The Assessing Office and Code Enforcement Office welcomes you to Gardiner! How would you like to save more money on taxes each year? Or find out what permits are needed to renovate your house? Keep reading to find out!

We have received a copy of the Real Estate Transfer for property you purchased this year in Gardiner. Your mailing address has been entered as it appears on the transfer document. To allow for expedient mailing in the future, please fill out the enclosed Change of Address/Information form; date of the move, if relocated; and any other information you feel is important.

If you believe you are eligible for any exemptions (tax savings!), i.e., Homestead, Veteran, Blind, or State Property Tax Rebate (Circuit Breaker program) please contact this office for an application or download all forms at <a href="https://www.gardinermaine.com">www.gardinermaine.com</a>. The Homestead Exemption has been enclosed for your convenience. If you have held an exemption in another town, it may be transferable with evidence of the previous exemption.

Tax bills are mailed to property owners in the month of August and are due in September and March. Since tax bills are mailed to the record owner as of April  $1^{st}$ , there is a chance you will not automatically receive a tax bill. Please contact the tax collector's office at 582-2223 to request a copy of the bill.

#### INSTRUCTIONS

Section 1. Check all three boxes indicating your answers. You must answer "Yes" to all three questions in order to qualify for the Maine homestead exemption. If you have moved during the year and owned a homestead prior to your move, indicate the name of the municipality you moved from on line B(1). Your ownership of homestead property must have been continuous for the 12 month period in question B. If you answer "No" to any question in this section you do not qualify for the homestead exemption.

<u>Section 2.</u> Indicate your full name(s) as shown on your property tax bill, the physical location of your home and your mailing address.

Section 3. This section gives the local assessor information which may be used to determine if you qualify and should support your answers to the questions in Section 1. Please check the appropriate answer for each of the statements in this section.

One or more of the owners of the homestead property may sign this document. Please file the application with your local municipal assessor. If, for any reason you are denied exemption by the assessor, you may appeal the assessor's decision under the abatement statute, Title 36 MRSA Section 841.

#### **DEFINITIONS**

#### 36 MRSA Section 681. Definitions

As used in this subchapter, unless the context otherwise indicates, the following terms have the following meanings.

- 1. Applicant. "Applicant" means an individual who has applied for a homestead property tax exemption pursuant to this subchapter.
- 2. Homestead. "Homestead" means any residential property in this State assessed as real property owned by an applicant or held in a revocable living trust for the benefit of the applicant and occupied by the applicant as the applicant's permanent residence. A "homestead" does not include any real property used solely for commercial purposes.
- 3. Permanent residence. "Permanent residence" means that place where an individual has a true, fixed and permanent home and principal establishment to which the individual, whenever absent, has the intention of returning. An individual may have only one permanent residence at a time and, once a permanent residence is established, that residence is presumed to continue until circumstances indicate otherwise.
- 4. Permanent resident. "Permanent resident" means an individual who has established a permanent residence.

#### Frequently Asked Questions

Q: Is there a citywide Clean Up?

A: Yes, the City does a Bi-Annual Fall Clean up. Please check the Website or call the Public Works Department for more information.

Q: You plowed in the end of my driveway. Why can't you lift the plow at my driveway?

A: We would love to be able to do that. However, it would make it nearly impossible to totally clean the travelway of the road.

Q: The sewer line from my house to the City's main in the street is plugged. Will you come and fix it?

A: The City maintains the house services to the edge of the road or the inside of the sidewalk, if a sidewalk is present. We will not do any maintenance from the edge of the road or sidewalk to the dwelling structure served by the connection.

Q: Can I come to the Public Works garage and get sand and salt?

A: Yes, Gardiner residents can come and get sand at the Public Works garage. We do not make salt available because it is quite expensive.

(): Do I call Public Works if I'm having trouble with my water?

A: No, you should call the Gardiner Water District at 582-5500.

(): Do I call Public Works if I have a question about my sewer bill?

A: No, you should call Becky Sieberg, the Sewer Clerk, at City Hall at 588-4070. If you need additional information, call Chuck Applebee, Wastewater Superintendent, at 582-1351.

Q: Where do I get rid of my brush and leaves?

A: Hatch Hill will accept leaves for free. There will be a modest charge for brush. Remember, you need to have a Hatch Hill permit to get in.

Q: How long will it take for the plow truck to get to my street?

A: It takes over 3 hours for a plow driver to complete his or her route, depending on the storm and how much snow falls. We plow all roads in Gardiner in a sequential order, you will not be forgotten.

If you are experiencing sewer problems, don't wait!! Call the Gardiner Public Works Department at 582-4408. The Public Works Department is responsible for responding to and resolving sewer complaints. The City maintains the sewer mains and house services to the edge of the roadway or the inside of a sidewalk if you have one in front of your house. If the obstruction is between the edge of the roadway or the inside of the sidewalk and your home, you should contact a plumber and have your line cleaned.

The mission of the Gardiner Police Department is to enhance the quality of life and provide a sense of safety and security within the City of Gardiner. Through highly dedicated employees, we are committed to the protection of all who live, work or visit our city. We serve the public twenty-four hours a day, 365 days a year.

#### How do I report an incident?

⇒ Emergencies can be reported by calling 911. An emergency can be defined as those situations where life or property is in danger. All other crimes can be reported by calling 582-3211. All other police business can be done by calling 582-5150.

#### **Animal Control Provisions**

⇒ Under Title 17, Chapter 7 of Gardiner's animal codes, certain provisions must be adhered to:

Section 1760:No dog shall be kept within the limits of the City of Gardiner unless such dog shall have been licensed by its owner in accordance with the statutes of the State of Maine. For the purposes of this chapter, "owner" shall mean any person or persons, firm, association or corporation owning, keeping or harboring a dog.

Section 1761: No owner of any dog shall permit such dog to run at large within the City of Gardiner. For the purposes of this chapter, "run at large" shall mean off the premises of the owner and not under the control of any person by leash, cord, chain or otherwise.

**Section 1762:** No owner shall keep or harbor any dog which by loud, frequent, or habitual barking, howling or yelping shall disturb the peace of any person or persons.
