#### 4. NEW BUSINESS

**a)** Presentation from Healthy Maine Communities Tobacco Prevention Coordinator April Hughes/Gardiner Police Officer Quintano - Regarding Alcohol and Marijuana Effects

Officer Quintana and April Hughes gave a presentation.

Councilor Berry asked Officer Quintana and April if the numbers have gone up. Patricia Welton spoke briefly and did not have the numbers but was willing to provide them. Councilor Berry asked a more of a general question about numbers. Patricia explained studies are done every other year.

Mayor Hart asked April to speak more about vaping. April spoke briefly.

Councilor White thanked Officer Quintana and April for their information and time.

Mayor Hart thanked them for being a part of the meeting.

b) Accept Grant from Coastal Communities for Downtown Master Plan

Manager Landes spoke briefly.

Councilor Cusick moved to accept the Coastal Communities Grant in the amount of \$33,750, to work on the completion of a new Downtown Master Plan.

Councilor Frey seconded.

Mayor Hart asked for any discussion. Seeing none. All those in favor. Unanimous.

c) Discussion Surrounding Speed Limit Set for Marston Road

Manager Landes spoke briefly. Jennifer and Ward Boudreau spoke about speeding on their road and the concerns.

Chief Toman spoke briefly about traffic safety.

Mayor Hart asked about cost and Manager Landes advised that DOT would cover the cost.

Mike Blanche asked to speak about the concerns on dropping the speed limit.

Councilor Cusick moved to allow the City Manager to request from the Maine Department of Transportation a speed analysis on Marston Road.

Councilor White seconded.

Mayor Hart asked for any discussion. Seeing none. All those in favor. Unanimous.

d) Discussion Surrounding Small Burns/Campfires in the HDR District

Councilor Frey spoke about campfire concerns.

Interim Fire Chief Rick Sieberg spoke about the complaints and they are mostly neighbor dispute.

Chief Toman spoke briefly they support the fire staff when needed.

Manager Landes spoke about how City of Rockland is struggling with this as well.

Councilor Frey spoke briefly how he was interested in sending this to ordinance review. Chair Willis said to send this to them at the Ordinance Committee.

Councilor Rees asked Councilor Frey if this was from one complaint.

e) First Read of Proposed Amendments to the City Code: Title 17 Chapter 5 Property Maintenance

Chair Willis spoke briefly about the city code.

Councilor Berry asked how are they are going to be more restrictive than at a state level.

Manager Landes explained this would be for homeowners as well for property owners.



Chair Willis explained this Proposed Amendment would give the Code Enforcement officer more enforcement.

Councilor Berry asked about the cost. Chair Willis explained it would be a fee of \$25 dollars daily. Chair Willis stated this is about the safe and sanitary conditions.

Councilor Rees expressed concern about the financial standpoint.

Councilor White spoke about her situation with her neighbor. The cost to her alone was about \$2000 dollars to get rid of the rats.

Councilor Rees received a letter from Robert Abby, he is not in favor and strongly believes it is not supporting a family friendly downtown.

I) Findings of Fact and Consider Approval of Medical Retail Marijuana/Dispensary: The Bud Bar

Councilor Cusick move to approve the Medical Retail Marijuana/Dispensary License for The Bud Bar as all approval standards have been met as noted in City of Gardiner Code Chapter 11, Section 5.2 for a term of 1 year with a condition they remain licensed.

Councilor Frey seconded.

Mayor Hart asked for any discussion. Seeing none. All those in favor. Unanimous.

j) Findings of Fact and Consider Approval of Retail Adult Use Marijuana Establishment: Sugar Bud Farms



Councilor Cusick move to approve the Retail Adult Use Establishment License for Sugar Bud Farms as all approval standards have been met as noted in City of Gardiner Code Chapter 11, Section 5.2 for a term of 1 year with the condition they remain licensed. Councilor Rees seconded.

Mayor Hart asked for any discussion. Seeing none. All those in favor. Unanimous.

 k) Consider Request from Backyard Dogs Catering Hot Dog Cart/Use of Common and Waterfront Park

Manager Landes spoke briefly.

Mayor Hart expressed concern about the hours and would like to limit them due to the community. Councilor Ault joined 8:02 pm

Councilor White move to allow Backyard Dogs Catering to place a mobile hot dog cart on the Common as long as all site requirements are adhered to and meet all the terms of the condition of the hours being 7am to 7pm.

Councilor Berry seconded.

#### 5. CITY MANAGER REPORT

- ➤ Lrep \$5,000 below than budgeted in the current year budget but the workers comp rate is \$17,000 savings.
- Excise collection was down \$21,000 in fiscal year 20 compared to year 19. As of today are up to \$15,000. It will be above this year.
- Monday night about 30-34 people show up to the Gardiner Grows held at Bateau Brewing.



- We learned that Monday Bridge project shut down for 30 days starting October 21st.
- Peek behind Reny's, Public works has been preparing the area for paving and it looks amazing.
- This afternoon City Manager Landes, PWD Douglas, Buildings and Grounds Supervisor Dan Robideau met with business owners down to McKay park. Received a \$25,000 grant to upgrade the park however in the spring there was granite removed. Made a plan to stabilize the area to get through to spring. They will start this week.
- Received a phone call from Patrick Adams to extend the path price has changed from \$60,000 to \$300,000 for 200 feet. This project has come to a halt. Mayor Hart asked for the drive for the cost.
