#### 3. PETITIONS/PUBLIC HEARINGS

a) Public Hearing of the Proposed Amendments to the General Assistance Ordinance

This will be a Public Hearing for proposed changes to the General Assistance Ordinance. These changes are initiated yearly by the State of Maine Department of Health and Family Services for consideration by each municipality.

#### 4. NEW BUSINESS



1. Consider Request from Phil Hart for Waterfront Park Memorial Bench

Phil Hart asked the City Council to consider and approve the placement of a memorial bench at the Waterfront Park. This park bench would be in memory of Donnie Mansir. Currently, there has been a donation of \$1,500 to pay for the bench in full. Should there be additional donations or the total cost does not exceed the \$1,500, any excess monies will be given back to the original donor. Tony LaPlante has offered to work with Mr. Hart on the placement of the memorial bench and coordinating a plaque to be attached in memory of Mr. Mansir.

Councilor Berry moved to allow the placement of a memorial bench at the Waterfront Park in memory of Donnie Mansir. The Public Works Director will work with the interested parties directly on the placement of such bench.

3. Consider and Sign the City of Gardiner FY20 Ambulance Service Contract

This agenda item is the approval and signing of the City of Gardiner's contract with the EMS department. The City of Gardiner's portion has a reduction of 5.54%. Affiliated municipalities have been billed.

Councilor Ault moved to approve the FY20 contract with the City of Gardiner's EMS Service. Councilor Cusick seconded. Mayor Hart asked for any discussion.

Councilor Rees asked how budget is calculated for all included Towns. City Manager Landes responded the numbers are based on calls and population.

Mayor Hart asked for any further discussion. Seeing none. All those in favor. Unanimous

4. Discuss, Evaluate, and Possibly Approve List A of Sewer Abatement Requests

The City Council will discuss, evaluate, and possibly approve the 'A' list of sewer abatement requests. Sewer abatement requests are reported quarterly to the City Council. Requests over \$150.00 require Council approval. See attached list for more information. List A: City Council consideration (over the \$150.00 threshold)



List B: City Council Special Consideration (outside water meter readings not given within the six (6) month ordinance window)

List C: Internal City Staff Approval (under \$150.00 threshold)

Councilor Rees moved to approve the Sewer Abatement Requests from List A, in the amount of <u>\$567.10.</u> Councilor White seconded. Mayor Hart asked for any discussion. Seeing none. All those in favor. Unanimous

5. Consider Amended and Restated Option and Predevelopment Agreement

Developer's Collaborative is asking for City Council approval to enter into an amended and restated option and predevelopment agreement. This option would extend the original agreement, acknowledging that the Grantee has closed on and acquired the Housing Project Option, to October 1, 2020. The option agreement would continue in full force and effect. Attached is the proposed amendment, and the original amended and restated option and predevelopment agreement that was signed on 7/24/2018 for 2 Highland Ave and 1 Summer Street.

Mike Lyne gave a brief overview of the project and agreement.

Councilor Ault moved to extend the amended and restated option and predevelopment agreement with Developers Collaborative until 10/1/2020 and allow the City Manager to sign the agreement. Councilor Berry seconded. Mayor Hart asked for any discussion. Seeing none. All those in favor. Unanimous

6. Consider Approval of Victualers License: Diggy Dogs Food Truck

The City Council is being asked to consider the approval of a Victualer license: Diggy Dogs They are a mobile food truck that will be vending their goods at Bateau Brewing on 9/20. As of the agenda posting, the business had not paid for the license, but they were told it would not be issued until payment was received in full. It was a matter of getting this application on as an agenda item in time for posting.

Councilor Cusick moved to approve a Victualers license for Diggy Dogs Mobile Food Truck. Councilor Ault seconded.

Councilor Cusick expressed his concern of the license fee.

City Manager Landes replied that there will be a proposal of the fees schedule in the upcoming meeting. You may wish to reduce the fee at that time.
