COUNCIL MEETING MINUTES GARDINER CITY COUNCIL WEDNESDAY, SEPTEMBER 5, 2018 6:00 PM

ROLL CALL

Mayor Harnett called the meeting to order at 6:41pm and requested roll call. Councilors: Patricia Hart, Marc Rines, Shawn Dolley, Tim Cusick and Terry Berry. Absent: Jon Ault and Maryann White. Also in attendance were Mayor, Thom Harnett; City Manager, Christine Landes and City Clerk, Kelly Gooldrup.

Audience: Christine Wallace, Matthew Marshall, Daniel Roche, Chris Bouchard, Paula Gardner, Brian Gardner and Hal Norvell

• PETITIONS, PUBLIC HEARINGS, PUBLIC COMMENT (anything not on the Agenda)

Robin Plourde, City Staff, spoke about the Tax and Sewer discount program. The deadline for the Tax program is October 15. We sent out letters to everyone who was in the program last year. There are 66 total, 37 of them have been returned. The sewer had 68. The Tax Collector, Kathy and I ran a workshop, but only 1 person showed up. We advertised it by putting up a sign, put it on the tax and sewer bills and word of mouth. I just wish there were more ways to get the word out. Mayor Harnett thanked Robin and Kathy for what they did.

Mayor Harnett also recognized Matt Marshall for serving on the committee to develop those programs.

NEW BUSINESS

1. Executive Session pursuant to 1 M.R.S.A. § 405 (6)(C): Discussion or consideration of the condition, acquisition, or the use of real or personal property permanently attached to real property or interests therein or disposition of publicly held property or economic development only if premature disclosures of the information would prejudice the competitive or bargaining position of the body or agency. (Discussion regarding a possible Credit Enhancement Agreement.)

Session began at 6:05 pm.to discuss a real-estate matter on a motion made by Councilor Cusick and seconded by Councilor Berry. Discussion ended at 6:23pm with a motion from Councilor Cusick and seconded by Councilor Berry.

2. Executive Session pursuant to 1 M.R.S.A § (6)(F): Discussion of information contained in records made, maintained, or received by a body or agency when access by the general public to those records is prohibited by statute. (Discussion regarding sewer abatement requests.)

6:24 pm entered executive session with a motion made by Councilor Cusick and seconded by Councilor Berry. After discussion, the session ended with a motion made by Councilor Cusick at 6:39 pm. Seconded by Councilor Berry.

3. Discuss and Possibly Approve to offer a Credit Enhancement Agreement to a Libby Hill Business Park Business

Councilor Berry made a motion to continue with City Staff negotiating with the applicant for the CEA and postpone the date to October 3. Councilor Cusick seconded. Any discussion? Seeing none, I will call a vote. All those in favor? Unanimous.

4. Discuss and Possibly Approve Sewer Abatement Requests

Councilor Hart move that we provide the abatement that was requested for the sewer bill for applicant number one. Seconded by Councilor Rines. Any discussion? Seeing none, I will call a vote. All those in favor? Unanimous.

Councilor Cusick made a motion that we provide the requested abatement by applicant number two. Seconded by Councilor Hart. Any discussion? Seeing none, I will call a vote. All those in favor? Unanimous.

5. Discuss, Evaluate, and Possibly Approve 'List B & C' of Sewer Abatement Requests.

City Manager Landes explain that any amounts under one hundred and fifty dollars is allowed to be abated by City Staff, List B requires Council approval if it is over one hundred and fifty dollars and List C would be a special consideration, they did not turn in their water meter readings within the six month allow Ent.

Doug Clark explained the sewer billing terms and deadlines. He is going to approve the past due one more time. The Waste Water Committee is meeting on September 25 and will talk about the ordinance and have a lot of changes. The language will be on the bills, written crystal clear. All accounts will receive a registered letter with information.

Christine Wallace, resident and sewer user, asked if she was getting an abatement. Doug Clark told her to go out front to speak with Sherry in the front office for an application.

Seconded by Councilor Dolley. Mayor Harnett asked for any discussion? Seeing none, I will call a vote. All those in favor? Unanimous.
