Councilors have in front of you a Holiday party invite scheduled for December 6, 2018 The City Manager met with Patrick Adams and Brian Keezer regarding the Cobbossee Trail issue. She did ask about the Bridge Project and he said it is on tap for next week. Dispatch discussions are continuing despite a couple brick walls. PSAP is 911 from Gardiner exchange. Dispatch Stations can be anywhere, but only one of fourteen PSAPs in the State. Thanks to Kelly and the Election Crew. Very smooth Election. There were quite a few absentee ballots front staff dealt with so I thank them for their patience on that. FY20 budget is starting soon.

Iron mine trailer park was granted an extension until 12/31/18. At that point I will return to the Council if they are not in a place to close the deal.

This year the City was able to offer the following to residents:

- 39 residents qualified for the tax discount program. They will be receiving payments ranging from \$100-\$500. The total would be \$11,797.
- 7 3 residents qualified for the Sewer Discount program, so they will get approximately \$9,600 in credits on their Sewer.
- $\circ~$ 123 Tax Clubs were set up, so those payments will be in nine monthly installments with no interest.

As of today, we have received twenty-two applicants for Economic Development position. Most are out of state, but I did have five in State so far.

Tree down at the corner that we had numerous discussions about is now gone.

Poverty abatement applicant has asked for an appeal, so it will go to Board of Assessment Review.

• CITY COUNCIL REPORT

Kelly Gooldrup responded that we did contract for two additional machines for this Election and will be keeping them.

Councilor Rines: Mayor Harnett it has been nice working with you. Looking forward to working with Pat. I am thankful that everyone else is still in their seats and look forward to another positive year with everybody.

Councilor Cusick: Congratulations to everybody. Kelly and the staff did a great job yesterday. There was a couple trying times yesterday. Kelly handled them very well. I was very impressed. I have some pictures of sidewalks and expressed concerns.
