4.) Review Comprehensive Plan Land Use Ordinance Amendments (Omnibus)

What you have to do if you plant new public trees. Language about replacement of Public trees (if the die, etc.) Protection around public trees (no stacking stuff against, etc.) If you are going to excavate around/near the tree, how you do it. Barb Skelton spoke about lack of care surrounding the Public properties, budgetary being partly to blame. Committee agreed to send it to John Pottle for further review.
