# **CITY OF GARDINER**

# Resolution of the Gardiner City Council on January 19, 2022, Regarding a Dangerous Building Located at 235 Water Street and Authorized Remedial Actions

**WHEREAS**, the building located on 235 Water Street, Gardiner, is in significant disrepair, structurally unsound, and in need of immediate corrective action; and

WHEREAS, the building was involved in a fire in July of 2015 that resulted in the complete removal of the abutting property to the south. Since the fire, little work has been done to the building to address the deterioration, bowing, fire damage, and lack of maintenance of the floor, roof, and wall framing which has created a substantial public safety hazard; and

**WHEREAS**, the building is located in the downtown area of Gardiner within a designated Historic District;

**WHEREAS**, the City recognizes the desire to maintain continuity in the downtown façade and maintenance and protection of historic features and character, but also that public safety is an important consideration in addressing the building at 235 Water Street; and

**WHEREAS**, the City has attempted to work with the owner of 235 Water Street over an extensive period of time to remedy the dangerous building conditions and these efforts to date have not resulted in a complete resolution; and

**WHEREAS**, the City has placed parking barriers outside the building to prevent the public from parking near the building due to the risk of falling debris; and

**WHEREAS**, the City initially consulted with A.E. Hodsdon Consulting Engineers to provide a report dated October 7, 2020, which describes observations of the dangerous condition of the building made during their site visit on September 24, 2020; and

**WHEREAS**, the City held a meeting on April 26, 2021, with the owner of 235 Water Street and abutters to the building as well as the City's Code Enforcement Officer; and

WHEREAS, the City has previously closed the outdoor dining space owned by Gerard's Pizza, which is adjacent to the building at 235 Water Street, due to concerns of brick debris falling from the building and concerns for diners should the debris continue to fall near the outdoor dining patio; and

**WHEREAS**, by notice dated August 3, 2021, the City provided the owner with a demand letter as a last attempt to satisfactorily address the building's dangerous condition to potentially avoid formal legal action; and

**WHEREAS**, the City further consulted with Wentworth Partners and Associates to provide a detailed October 15, 2021, engineering structural evaluation report of 235 Water Street, attached to this resolution as Exhibit A ("the Wentworth Report"); and

**WHEREAS**, the Wentworth Report describes the severe and pervasive deterioration of the building concluding that that the building is considered unsuitable for any purpose and that the disrepair is considered dangerous; and

WHEREAS, the Wentworth Report sets forth options to address the dangerous building conditions described therein taking into account structural considerations with adjacent buildings and other property owners; and

WHEREAS, the City has shared the Wentworth Report with the owner, who has engaged in discussions with the City Solicitor for potential resolution of the dangerous building conditions; and

**WHEREAS**, in the judgment in the City Council, the City of Gardiner has made reasonable attempts to have the owner address the dangerous conditions; and

**WHEREAS**, the City Council desires to adopt this Resolution to provide a summary of the steps the City has taken to date to address the building located on 235 Water Street, and to authorize further actions, including legal actions if necessary, to provide resolution of the dangerous conditions.

**NOW THEREFORE, IT HEREBY IS RESOLVED**, That the City Council, based upon the above, finds the building located at 235 Water Street is a dangerous building; and

**BE IT FURTHER RESOLVED**, That the City Solicitor is hereby authorized to take any and all measures necessary and appropriate to resolve the dangerous conditions of the building located at 235 Water Street, including without limitation taking all necessary legal actions in court; and

**BE IT FURTHER RESOLVED**, That the City Code Enforcement Officer in his judgment may continue to take all necessary and appropriate actions to protect the public health, safety, and welfare consistent with the laws and regulations of the City of Gardiner and State of Maine.
