Subject: Marijuana Facilities Licensing Fees

At the May committee meeting, the ORC reviewed the proposals for revising the fees for the licensing of marijuana facilities. The ORC agreed on the following:

1. Amend the licensing ordinance adopted by City Council to remove the fees from the ordinance and require that a fee be paid based on the City Council adopted fee schedule.
2. Recommend that the fees as adopted in the licensing ordinance be included in the fee schedule.
3. Add a provision in the fee schedule that caps the fees paid for multiple facilities on the same lot at \$2,500.

Based on these considerations I've prepared a draft memo to the City Council outlining these recommendations including an amendment to the existing ordinance.

As requested by the City Council, the Ordinance Review Committee reviewed the City's approach for establishing fees for licenses for both medical and adult-use marijuana establishments and for the amount of those fees. The Committee is recommending that the Council do the following:

1. Amend the Marijuana Establishment Licensing Ordinance to delete the fees set forth in Section 8 of the adopted ordinance and replace it with a provision that requires a fee to be paid in accordance with the schedule of fees adopted by the City Council. A proposed amendment to Section 8 is attached. This amendment should be adopted only when the City Council has adopted the fees as part of the fee schedule.
2. Adopt the fees that will be deleted from the licensing ordinance as part of the City's fee schedule. After reviewing those fees in comparison to other communities and the level of oversight called for by City staff, the Committee believes that the fees are reasonable. A spreadsheet showing the fees being charged in other communities is attached. A recommendation for the revision to the fee schedule is attached.
3. To account for situations where more than one licensed facility is located on the same lot, the Committee recommends that the total licensing fee paid for all marijuana facilities located on the same lot be capped at \$2,500. For example there could be a facility that is licensed both as a manufacturing facility and as a retail store. The separate fees would be \$3,500 (\$1,500 + 2,000) but with this provision the fee would be capped at \$2,500. This provision is included in the proposed fee schedule that is attached.

The Ordinance Review Committee would be happy to discuss these recommendations with the City Council.

Amend Section 8. Fees of the Marijuana Establishment Licensing Ordinance to read as follows:

Section 8. Fees

An application for a license or renewal of a license for a marijuana establishment shall include an application fee in the amount set forth in the schedule of fees adopted by the City Council. ~~following table:~~

This fee is nonrefundable and will be used to offset the City's costs in the review of the application and in the oversight with respect to conformance of the establishment with respect to the license and any conditions of approval.

## Proposed Amendment to the City's Fee Schedule

Amend the City's Fee Schedule by adding a section establishing fees for the licensing of marijuana establishments in accordance with the Marijuana Establishment Licensing Ordinance:

**Fee for a license or the renewal of a license for a marijuana establishment:**

Each application for a license or the renewal of a license for a marijuana establishment in accordance with the Marijuana Establishment Licensing Ordinance shall pay a fee as set forth below. If more than one licensed marijuana establishment is located on the same lot and the licenses are issued to the same party, the total fee for all licenses or license renewals in a calendar year shall not exceed \$2,500.
