Background Information

The City of Gardiner has received a Community Enterprise Grant through the Office of Community Development in the amount of \$25,000. This grant is earmarked for McKay Park.

As part of Phase II of the grant, City Council through a public hearing process must accept the grant funds.

The city is responsible for a 25% match that will include in-kind services to meet this requirement.

STATE OF MAINE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the City of Gardiner wishes to apply to the Department of Economic and Community Development for a Community Development Block Grant to carry out a community development program; and

WHEREAS, the planning process required by Maine Law and the CDBG Program have been complied with, including participation in the planning process by low and moderate income families and individuals and **the community has conducted at least one duly advertised public hearing**; and

WHEREAS, the City of Gardiner is cognizant of the requirement that should the intended National Objective of the CDBG program not be met all CDBG funds must be repaid to the State of Maine CDBG program; and

NOW THEREFORE, be it resolved by the Council of the Community of Gardiner that the City Manager (or other local government official or officer):

- 1) Is authorized and directed to submit an application for the following program(s) and dollar amount(s) within the State of Maine's CDBG Program:

Program: Community Enterprise Grant Amount: \$25,000

To the Department of Economic and Community Development on behalf of the Community of Gardiner, substantially in the form presented to this council;

- 2) Is authorized to make assurances on behalf of the Community of Gardiner required as part of such applications, and
- 3) Is authorized and directed, upon acceptance of said funds to carry out the duties and responsibilities for implementing and said program(s), consistent with the Charter of the Community of Gardiner and the laws and regulations governing planning and implementation of community development programs in the State of Maine.
