WARRANT AND NOTICE OF ELECTION CALLING MAINE SCHOOL ADMINISTRATIVE DISTRICT NO. 11 BUDGET REFERENDUM

(20-A M.R.S. § 1486; Executive Order #56 FY 19/20)

TO: Ginger Shaw, a resident Maine School Administrative District No. 11 (the "District") composed of the City of Gardiner and the Towns of Pittston, Randolph, and West Gardiner, State of Maine.

In the name of the State of Maine, you are hereby ordered to serve upon the municipal clerks of each of the municipalities within the District, namely, the City of Gardiner and the Towns of Pittston, Randolph, and West Gardiner, an attested copy of this warrant and notice of election. Service shall be in hand within three (3) days of the date of this warrant and notice of election. The municipal clerks of the above municipalities shall immediately notify the respective Municipal Officers. The Municipal Officers shall meet forthwith and countersign this warrant and notice of election. The Municipal Officers shall provide below for the respective municipal clerks to post or have posted this warrant and notice of election.

TO: James Toman, Resident of Gardiner: You are hereby required in the name of the State of Maine to notify the voters of this municipality of the election described in this warrant and notice of election.

TO THE VOTERS OF GARDINER: You are hereby notified that a District Budget Referendum election will be held at Gardiner Area High School, 40 West Hill Road in the City of Gardiner on Tuesday, July 14, 2020 for the purpose of determining the following questions:

Question 1. School Budget. Shall Maine School Administrative District No. 11 appropriate the sum of \$26,161,000.00 and raise the sum of \$9,974,437.35 for the 2020-2021 school budget?

School Board Recommends a "Yes" Vote.

VOTER INFORMATION FOR QUESTION 1

The Maine School Administrative District No. 11 school budget submitted in this Question 1 totals \$26,161,000.00. It includes locally raised funds in the amount of \$9,974,437.35, to be assessed in shares to member municipalities in accordance with the District's cost sharing formula and state law. The locally raised amount exceeds the maximum state and local spending target by \$2,229,267.01. This budget includes these cost centers and amounts:

- Question 2. District Adult Ed Program. Shall the District be authorized to appropriate \$300,000.00 for adult education and raise \$105,450.00 as the local share, with authorization to expend any additional, incidental, or miscellaneous receipts in the interest and for the well-being of the adult education program?

 School Board Recommends a "Yes" Vote.
- Question 3: Special Education Reserve Fund. Shall the School Board be authorized to establish a Special Education Reserve Fund for unexpected special education costs; to transfer up to \$300,000.00 from available fund balances to said Reserve Fund; and to expend said Reserve Fund to pay any unexpected special education costs during the 2020-2021 school year?

 School Board Recommends a "Yes" Vote.

The polls must be opened at 8:00 a.m. and closed at 8:00 p.m.

The Registrar of Voters shall hold office hours while the polls are open to correct any error in or change a name or address on the voting list; to accept the registration of any person eligible to vote and to accept new enrollments.

A person who is not registered as a voter may not vote in any election.
