BE IT ORDERED BY THE COUNCIL OF THE CITY OF GARDINER, MAINE:

1) **ORDERED**, That the City Council hereby authorizes the City Manager, Code Enforcement Officer, or the City Clerk to review and approve or deny all requests to hang banners on city property, on behalf of the Municipal Officers, during the period of January 1, 2021 through December 31, 2021.

2) **ORDERED**, That the City Council hereby authorizes the Mayor to act on its behalf, to excuse the City Manager from City Council meetings on the grounds of illness or other circumstances, during the period January 1, 2022 through December 31, 2022.

3) **ORDERED**, That the City Council authorizes the Mayor to act on its behalf, to authorize Chief James Toman to be the first designee to the (Acting) City Manager including signatory duties and that Chief Richard Sieberg be the second designee to the above duties during the period January 1, 2022 through December 31, 2022.

4) **ORDERED**, That the City Council hereby authorizes the City Clerk and/or Deputy City Clerk to sign all applications to operate beano, bingo or other games of chance on behalf of the Municipal Officers, during the period January 1, 2022 through December 31, 2022.

5) **ORDERED**, That the City Council hereby authorizes the City Clerk and/or Deputy City Clerk to approve and sign all business licenses on behalf of the Municipal Officers, during the period January 1, 2022 through December 31, 2022, after review by all Department Heads and Code Enforcement.

6) **ORDERED**, That the City Council hereby authorizes the City Clerk and/or Deputy City Clerk to approve and sign all applications for utility pole permits on behalf of the Municipal Officers, during the period January 1, 2022 through December 31, 2022.

7) **ORDERED**, That the City Council hereby authorizes the Public Works Director or Supervisor, or City Manager in the Director's absence, to sign Street Opening Permits on behalf of the Municipal Officers, during the period January 1, 2022 through December 31, 2022.

8) **ORDERED**, That the City Council hereby authorizes the City Manager to sign Off-Premise Liquor License Applications from Licensed Liquor Establishments with the agreement that the caterer's license is in current and good standing with the City, and there are no other concerning issues surrounding the serving of alcohol, during the period of January 1, 2022 through December 31, 2022.
