- 1) **ORDERED**, That the City Council hereby authorizes the City Manager, Code Enforcement Officer, or the City Clerk to review and approve or deny all requests to hang banners on city property, on behalf of the Municipal Officers, during the period of January 1, 2020 through December 31, 2020.
- 2) **ORDERED**, That the City Council hereby authorizes the Mayor, to act on its behalf, to excuse the City Manager from City Council meetings on the grounds of illness or other circumstances, during the period January 1, 2020 through December 31, 2020.
- 3) **ORDERED**, That the City Council hereby authorizes the City Clerk and/or Deputy City Clerk to sign all applications to operate beano, bingo or other games of chance on behalf of the Municipal Officers, during the period January 1, 2020 through December 31, 2020.
- 4) **ORDERED**, That the City Council hereby authorizes the City Clerk and/or Deputy City Clerk to approve and sign all permits for a circus or carnival on behalf of the Municipal Officers, during the period January 1, 2020 through December 31, 2020.
- 5) **ORDERED**, That the City Council hereby authorizes the City Clerk and/or Deputy City Clerk to approve and sign all business licenses behalf of the Municipal Officers, during the period January 1, 2020 through December 31, 2020 after review by Fire Chief, Police Chief and Code Enforcement.
- 6) **ORDERED**, That the City Council hereby authorizes the City Clerk and/or Deputy City Clerk to sign all Off-premise Catering and Liquor permits on behalf of the Municipal Officers, during the period January 1, 2020 through December 31, 2020 after review by Fire Chief, Police Chief and Code Enforcement.
- 7) **ORDERED**, That the City Council hereby authorizes the City Clerk and/or Deputy City Clerk to approve and sign all applications for utility pole permits on behalf of the Municipal Officers, during the period January 1, 2020 through December 31, 2020.
