According to Maine State Law, MRS Title 21-A, Chapter 7. ELECTION OFFICIALS, election staff (Republican, Green Independent, and Democratic poll workers) must be approved in even years for two years.

Appointment: The municipal officers shall appoint election clerks by May 1st of each general election year to serve at each voting place during the time the polls are open and as counters after the polls close. In making the appointments, the municipal officers shall consider all nominations received by April 1st but may appoint any qualified voters. A list of the election clerks appointed under this subsection must be posted at each voting place for each election during the 2-year term following appointment.
