2. Council Consideration of a Proposed Road Name/Okami Path

Code Enforcement Officer McNeill received a request to name a private road off from 87 West Hill Road as Okami Path. Part of the property has been sold and another home will be located off the private driveway. According to Chapter 10 of the 911-Enhanced section of the City of Gardiner Code: "all public or private roads serving two or more addresses shall be named." The request complies with the criteria that "no two roads shall be given the same or similar-sounding (e.g. Beech and Peach, Pine Road and Pine Lane) names. Currently there are no other roads in the City of Gardiner with a similar name.

Councilor Cusick moved to approve the private road name of Okami Path, that will be located off the current 87 West Hill Road.
