- 2) ORDERED, That the City Council hereby authorizes the Mayor to act on its behalf, to excuse the City Manager from City Council meetings on the grounds of illness or other circumstances, during the period July 1, 2023 through June 30,2024.
- 3) ORDERED, That the City Council authorizes the Mayor to act on its behalf, to authorize Chief Richard Sieberg to be the first designee to the City Manager including signatory duties and the Chief Todd Pilsbury be the second designee to the above duties during the period of July 1, 2023 through June 30, 2024.
- 4) ORDERED, That the City Council authorizes the City Clerk and/or Deputy City Clerk to sign all applications for beano, bingo or other games of chance on behalf of the Municipal Officers during the period of July 1, 203 through July June 30, 2024.
- 5) ORDERED, That the City Council hereby authorizes the City Manager to approve and sign all business licenses behalf of the Municipal Officers, during the period July 1, 2023 through June 30, 2024 after review by all Department Heads and Code Enforcement.
