Several members express the status and safety of this building. Kris McNeill CEO, has met with Mr. Coulombe, who disclosed that he has plans for the building, stating he is interested in turning it into offices. Given the history of this building, Commission members would like more information. This will be discussed by City Council on 7/21/21. Attorney Pottle will be attending the meeting to assist with legal matters. There have been 2 engineering studies that state that there are structural issues due to the fire. There is currently no plan to improve the structural integrity of the building. Chair Doyle expresses that with no applicant, they cannot discuss the application.
