Kris has proposed revising the treatment of various types of marijuana establishments involved in retail sales. I will let him explain his reasoning for this. I have put together some draft amendments that do the following:

- Combines Marijuana Retail Store, Medical Marijuana Registered Caregiver Retail Store and Medical Marijuana Registered Dispensary that involves retail sales into one use that I have called Marijuana Retail Sales Establishment
- Creates a new definition for Marijuana Retail Sales Establishment
- Creates a new definition for Medical Marijuana Registered Dispensary with Retail Sales
- Revises the definition for Medical Marijuana Registered Dispensary to eliminate retail sales
- Removes Marijuana Retail Store and Medical Marijuana Registered Caregiver Retail Store from the Table of Uses for commercial uses
- Adds Marijuana Retail Sales Establishment to the Table of Uses
- Adds Medical Marijuana Registered Dispensary back into the Table in a different location
- Revises where Medical Marijuana Registered Dispensary is allowed now that retail sales are not included to match cultivation

Here are drafts of the amendments:

1. Amend Section 17 Definitions to add a definition of Medical Marijuana Registered Dispensary with Retail Sales in proper alphabetical order to read:

Medical Marijuana Registered Dispensary with Retail Sales: An establishment licensed by the State of Maine as a Registered Medical Marijuana Dispensary in accordance with the rules established under Title 22 M.R.S. Chapter 558-C that involves the retail sales of marijuana or marijuana products at a fixed location.

2. Amend the definition of Medical Marijuana Registered Dispensary in Section 17 to read:

Medical Marijuana Registered Dispensary: An establishment licensed by the State of Maine as a Registered Medical Marijuana Dispensary in accordance with

the rules established under Title 22 M.R.S. Chapter 558-C <u>that does not involve</u> <u>the retail sales of marijuana or marijuana products at a fixed location</u>.

3. Amend Section 17 Definitions to add a definition of Marijuana Retail Sales Establishment in proper alphabetical order to read:

Marijuana Retail Sales Establishment: A Marijuana Retail Store, a Medical Marijuana Registered Caregiver Retail Store, or a Medical Marijuana Registered Dispensary with Retail Sales

4. Amend the Table of Land Uses in Section 7.6 as shown in the following fragments of the table
