We, the undersigned, Leo V. Standish, Charles H. Williams and Fred E. Patten, a committee of the City Council of the City of Gardiner, duly appointed at a regular meeting of the said body, held on Julyplst, 1935, and appointed to lay out a Town way as described in the petition of R. H. Gardiner presented at said meeting of July 1st, 1935, do hereby give notice of our intention to lay out said town way as bounded and described in said petition and plan attached thereto, said town way to be bounded and described as follows:

Beginning at a point on the northerly line of Cottage Street as now laid out, and about four hundred (400) feet in a westerly direction from River Avenue, so-called, and thence four hundred fifteen (415) feet in a northwesterly direction to a stake located on the northerly line of property of R. H. Gardiner, and known as "The Oaklands" at a point on said line where the westerly line of land of one William Hayes and the easterly line of land of one Fred Eugley four hundred thirty-two (432) feet in a straight line and in a westerly direction on and along the northerly line of said Gardiner to a stake located on the easterly line of Dresden Avenue so-called, and then beginning at a stake on the westerly side of Dresden Avenue aforesaid directly opposite on said Dresden Avenue from the bound referred to on the easterly side of the road, and thence about three hundred thirty (330) feet in a straight line and in a south-southwesterly direction to a stake located on the easterly line of Lincoln Avenue so-called; said line as described above to be the northerly line of said new way, which is to be 49.5 feet wide at all points, and to be laid out as described in the petition of R. H. Gardiner referred to above, and located on the plan attached thereto and made a part of said petition.

Dated at Gardiner, this fifth day of July, A. D. one thousand nine has hundred thirty-five.
