## Page 27 Lincoln Street Continued and Danforth Street

On The petition of E. F. Deane and nine other scitizens of the town of Gardiner, and in pursuance of notice publicly given according to law the undersigned Selectmen of the town of Gardiner have proceeded to view the location for streets as requested by said petitioners, and have laid out the same as follows, to wit: Commencing on the westerly line of the Parsonage lot at the south westerly corner of A. F. Perkins lot and running on the line of the said Parsonage lot about 12 rods to land owned by Ebenezer F. Deane Esq. the line above described is the easterly line of said Street, and the Street to be three rods wide.

Also a street leading from Lincoln Street to Dresden Street as follows, Commencing on the easterly line of said Lincoln Street at the aforesaid south westerly corner of A. T. Perkins lot, thence running on the southerly line of said Perkins lot and the lot owned by Ivory Nudd to the Dresden Street about twenty rods; the above described line to be the northerly line of the street and the street to be three rods wide.

All which is submitted for the action of the town

side note: The town voted to accept the continuation of Lincoln Street to E. F. Deane land and also to accept the street from Lincoln Street to Dresden Street across the parsonage providing, the damages shall not exceed thirty five dollars.

Description of a Town Road laid out and established by the County Commissioners Aug. 15, 1848 on petition of A. F. Perkins & 18 others - the Selectmen having unreasonably refused to lay out the same.

Commencing at the Southwest corner of A. F. Perking lot on Lincoln Street and running N. 73° E. 20 rods on the South line of A. F. Perkins' Lot, and on the south line of James Nash and Ivory Nudd's lot to Dresden Street, said road to be 40 feet wide and on the east (south) side of the course and distance.

The County Com. also estimated the damages sustained by the Warden's of Christ Church Parish at the sum of Two Hundred and three dollars 33 cents and awarded damages to no other person.

The Committee on laying out new streets and assessing damages therefor to which was referred the petition of John Dennis and others, having attended to that duty, beg leave to submit the following - Report

That after giving legal notice to all persons interested - We proceeded to examine the premises and after a careful examination, your committee on mature deliberation have concluded to recommend, and do recommend that a new Street be laid out as prayed for by John Dennis and others as follows - Commencing at the south easterly corner of land owned by the heirs of John Haseltine, and thence running south 17 degrees east across land owned by Jas. R. Byram 12 rods to the north easterly corner of land owned by Henry B. Hoskins - thence continuing the same course across land owned by Wm. B. Grant

#### DENNIS STREET

This is an excerpt from "Alteration of Vine Street" - Page 119.

The instructions in relation to fixing the grade of said Street were not followed by the committee for want of time and partly because it was deemed advisable when this work was done that the grade of School Street also, and Dennis Street should be taken into the account. The Committee would venture to suggest that there would be a propriety in terminating Vine Street at R. Thompson corner and making the remainder of the present Street from that point to School Street a part of Dennis Street, or in other words letting Dennis Street commence on the line of School Street and Vine Street intersect with Dennis Street.

The Joint Standing Committee on Laying Out New Streets, who were instructed to lay out a street from the Gardiner and Pittston Bridge to the east line of Main Street, so called, beg leave to Report that they have laid out a new street beginning at a point six and one half  $(6\frac{1}{2})$  inches north of the north east corner of J. C. Morrison's Building, said point being at the north east corner of said Morrison's lot; thence running south  $86\ 3/4^{\circ}$  west one hundred twenty-two and one half  $(122\frac{1}{2})$  feet, passing two (2) feet north of the north east corner of A. Bailey's Building, to the southeasterly line of Causeway Street, the line above described to be the south line of said Depot Street and the street to be thirty (30) feet wide. The conditions are, that no land damage shall be paid by the City. All of which is respectfully submitted.

Causeway Street and Main Street from the north end of Causeway to the Farmingdale line shall be called Maine Avenue. Main Street from the north end of Bridge Street to said north end of Causeway, shall be called Bridge Street. And Depot Street shall be called Depot Square.

Therefore, Main Avenue shall extend from 199 Water Street to the Farmingdale line.

Depot Square from No. 17 Maine Ave. to the Maine Central R. R. And Bridge Street from No. 351 Water Street from No. 351 Water Street from No. 184 Main Avenue.

M. and proceeded to the location of the street, prayed for and after a thorough examination of the premises, we proceeded to lay out the street as follows: commencing at the N. E. corner of the lot occupied by the Johnson House on Water Street running on the Easterly line of the said Johnson House Southerly 82 feet to the line of Mechanic Street, the said new street to be 12 feet wide paralell with the Easterly line of the said Johnson House and we have assessed the damages as fourteen hundred dollars-one thousand dollars of the above sum to be paid by the city and four hundred dollars to be paid by Benjamin Johnson,

R. at the south west corner of Eleazer Tarboxs land, thence 58° east to the river road a few rods northerly of Smiths Ferry landing, the said line designates the easterly line of said road which is laid out four rods wide. Page 144 Note. The exact distance between Lincoln & Dresden Streets on School Street is  $336\frac{1}{4}$  feet.

Ordered, the Common Council concurring, that the names of Brunswick Street, Washington Street, Lincoln Street, Central Street, Main Street, Dresden Street, and the street known as River Road, (from its junction with Kingsbury Street to the Richmond line) be changed to Avenues.
