That they did on the 10th day of November 1859 proceed to view ground for said street and have laid out the same as follows viz. Begining at the monument (F) on the north easterly corner of Temple Lot and on the southerly side of Brunswick Street. southerly ranging with the westerly line of Lincoln Street 111 ft. 8 inches to School Street ( to bound E on plan) Thence north easterly on line of School Street 48 feet 8 inches to the south west corner of Brunswick Square. Thence northerly and on the westerly line of said Square 151 feet 5 inches to the point of intersection with the southerly line of Brunswick Street (G) thence south westerly on said southerly line to the first bound (F) at which point the proposed street is 53 ft. 9 inches wide. Said street being the continuation of Lincoln Street, all which is respectfully submitted together with plan of said street.

### Noyes' Minutes

Noyes' notes and minutes in relation bounds of streets - encroachments upon them or made when surveying and locating the streets in 1859. "All the monuments marking the City Survey are Granite posts about 8 inches square and marked with the letter M, or iron rods from 3 to 4 feet long set in Granite blocks and buried so as to leave but an inch or two above the surface at the ground in the true angle. And where a ledge occurs the angle is marked by a drilled hole with a letter M near it. In all cases the Granite posts are set entirely in the streets so that the corner made by its two outer sides is the angle.

Care should be used by the street commissioner not to mistake any of the numerous stones marking division lines for the boundaries of the street lines.
